

**The 2016 Master Class Scholarship Competition  
dedicated to Members of the MINY Media Center by IFP  
to be awarded for the NEGOTIATING DEALS Master Class,  
taking place in New York, USA,  
from the 19<sup>th</sup> – 22<sup>nd</sup> November 2016**

**– Scholarship Application & Entry Rules –**

1. The ENTERTAINMENT MASTER CLASS (the “EMC”) will award one (1) scholarship (each a “Master Class Scholarship”, together the “Master Class Scholarships”) to Members of the MINY Media Center by IFP for attending the upcoming Master Class on “NEGOTIATING DEALS”, taking place in New York, USA, from the 19<sup>th</sup> – 22<sup>nd</sup> September 2016 (the “2016 NEGOTIATING DEALS Master Class”).
2. This Master Class Scholarship for the upcoming 2016 NEGOTIATING DEALS Master Class in New York will cover the full €4,000 (in words: four thousand Euros) tuition fee of the selected candidate, but it does not cover any hotel accommodation nor travel costs. The Master Class Scholarship for the upcoming 2016 NEGOTIATING DEALS Master Class in New York cannot be paid out in cash nor transferred to another person.
3. The Master Class Scholarship is dedicated solely to a Member of the MINY Media Center by IFP. Everyone who is a Member of the MINY Media Center by IFP or works for a company that is a Member of the MINY Media Center by IFP is eligible to enter this scholarship competition. The scholarship winner will be selected from all those eligible Members of the MINY Media Center by IFP who apply for this Master Class Scholarship.
4. In order to enter this scholarship competition, Members of the MINY Media Center by IFP must submit their application for this Master Class Scholarship to the EMC (the “Scholarship Application”). The Scholarship Application must include:
  - **A curriculum vitae (CV), summarising the candidate’s work experience in the English language; and**
  - **A duly completed application form.**

5. This Scholarship Application must be sent by email to the EMC and must be received **no later than Wednesday, the 9<sup>th</sup> November 2016** (the “Scholarship Application Deadline”). The EMC cannot guarantee that late applications will be processed. Late or incomplete applications may be declared ineligible.
  
6. From all eligible Scholarship Applications received, the MINY Media Center by IFP will select the winner who will receive the Master Class Scholarship for the 2016 NEGOTIATING DEALS Master Class in New York. The candidate should be fluent in English and willing to share their industry experience and knowledge. The Scholarship Winner will be notified in writing by the EMC. All rulings of the EMC in all matters relating to the selection process shall be binding and final.
  
7. The EMC is a limited liability company operating as a not-for-profit organization dedicated to peer-to-peer executive education in television entertainment. The EMC is formed and registered as a so called “gemeinnützige Gesellschaft mit beschränkter Haftung” (gGmbH) governed by the laws of the Federal Republic of Germany.
